A Few Changes to Chapter Rules

With this newsletter is a document from international that shares new wording for chapter rules resulting from the amended constitution and standing rules adopted at the 2022 International Convention.

The chapter rules that are to be changed are identified in the column Affects Chapter Rules. It is easiest to remove the item addressed in your rules and replace it with the words in the column New Wording.

The amendments are identified as PA (Proposed Amendment) and a number. For PA 55 and PA 65 the wording is not given as it refers to removing the induction fee. Please remove from your chapter rules any reference you have to the induction fee.

After revising your chapter rules, please use a group email to send them to the Rules Committee so they have the updated version of your rules. Please send your updated rules to the committee by November 1. The amended rules do not need approval of the chapter as they come from international. Thank you for helping your chapter accomplish this task!
